Various impacts are more closely defined as increasing access to nutritious food, improving childcare and education and providing safety net services. On September 10, 2017, a category 4 Hurricane - Irma made landfall in the Florida Keys. The Organization established and Irma Relief Fund for donations for this natural disaster. The disaster relief fund raised 1.66 million for relief efforts. UWFK's disaster relief fund is being distributed to nonprofits and individuals throughout Monroe County for direct hurricane recovery aid. This aid is continuing into the next fiscal year.
